

GRAND-VILLE - OFFICIAL RULES

1. **PROMOTION DESCRIPTION:** The Grand-ville \$1,000 weekly giveaway begins on Saturday 1st June at 7.00am and ends on Friday 28th June at 7.00pm (the "Promotion Period").
